I established Black Pearl Chamber Orchestra as a model for the 21st century orchestra: a world-class music ensemble that makes a visible commitment to cultural diversity at every level of the organization and uses innovative community engagement activities and artistic collaborations with some of the city's most prominent cultural institutions to attract new audiences to classical music. The ultimate aim of Black Pearl is to take the entire community beyond spectatorship to participation in the artistic experience.

Accomplishments include

- ❖ Securing over \$2.2M in corporate, government, private foundation, and individual contributions.
- ❖ Designing compelling artistic projects and drafting successful federal grant applications that have received funding from the National Endowment for the Arts annually since 2009.
- ❖ Conceiving and designed three innovative community engagement concerts that each received a prestigious Knight Arts Challenge grant, making Black Pearl the only organization in the nation ever to win three such awards.
- ❖ Developing an organizational brand that attracts an age, socio-economic and culturally- diverse audience. Black Pearl concert audiences are 60% African-American and Latino- a unique audience demographic among classical music organizations not only in Philadelphia, but in the nation. BPCO audiences are also age and income diverse as 50% of our audience under the age of 50 and 34% report an annual income below \$50,000, 36% report an annual family income between \$50,000 and \$100,000 and 28% over \$100,000.
- ❖ Conceiving and performing programs that combine classical music with poetry, literature, visual arts, and technology in collaboration with leading Philadelphia cultural institutions including the Free Library of Philadelphia, Opera Philadelphia, WHYY, and the Barnes Foundation.
- ❖ Representing Black Pearl for numerous press briefings, television and radio interviews, and been invited to speak at the 2014 League of American Orchestras annual conference in Seattle, WA to discuss Black Pearl's innovative community engagement programming

Conductor and 2005 MacArthur Fellow Marin Alsop founded the Fellowship in 2002 with the mission to foster and encourage women who are studying or training to be orchestral conductors. - ❖ **Comcast/NBC Universal** In 2015 I lead a unique afternoon program that used the art of conducting an orchestra to foster effective leadership and innovative thinking for more than 100 of Comcast's diversity and inclusion managers from across the United States.
- ❖ **Philadelphia Chamber Music Society** In 2008, PCMS was seeking a way to attract a younger and more diverse audience for their world-class chamber music series. I provided a strategy, action plan and programming ideas for connecting with local civic groups that serve the African-American and Latino communities in Philadelphia.
